- If access approval is granted to the archives collection, and an applicant wishes to make photocopies of sought material, they will be responsible for the costs of doing so through the Museum, unless alternative arrangements are made with Museum staff.
- If access approval is granted to the objects and photographic collection, and an applicant wishes to make digital copies of sought material, they will be responsible for the costs of doing so unless alternative arrangements with the Museum are made.
