Sylvie Brassard is a PhD candidate in History at UWA. She is part of Émilie Dotte-Sarout's project, Pacific Matildas: Finding the Women in the History of Pacific Archaeology. She is especially interested in the case of the Musée de l'Homme in Paris, France, and looks at how women's contribution to sciences was erased from historiographical narratives. Sylvie was born and raised in Québec, Canada. She completed a bachelor's and master's degree in history at Université Laval (Québec, Canada). She worked primarily on handwritten notary acts from the 16th century and their implication in extrajudicial procedures in Southern France.
